
1. Overview



This section provides an overview of callers to the charity's helpline in August 2022. The dataset comprises completed advice cases only (this means cases where a full financial assessment has taken place and a debt solution has been recommended).

The charity's helpline advisers dealt with a total of £277,661 of unsecured debt in August 2022 at an average of £14,614 per case (full financial assessments).




c1.2 Unsecured debt profile (August 2022)






In August 2022, 36.8% of callers told us they'd previously sought help with their debts. 42.1% of callers were identified as having a vulnerability that made them susceptible to potential detriment.

c1.7 Priority debt arrears (August 2022)²



c1.8 Priority debt arrears by type (August 2022)








The age group with the highest average unsecured debt in August 2022 was the 45-54 age group (£18,778). The age group with the highest helpline engagement was the 35-44 age group, which was 161% more likely to call the helpline than the UK average.





c2.3 Unsecured debt by type (August 2022)











Males had the highest average amount of debt in August 2022 (£24,018). The highest weighting of callers to the helpline in the period was females (68%).

















c4.3 Unsecured debt by type (November 2018)
























Full-time employment was the group with the highest average unsecured debt (£22,998) in August 2022. Disabled or sick was the most likely group to call us for advice (42%).
































